AGE APPROPRIATENESS

Dialysis vs. Kidney Transplant- Estimated Survival in Ontario is intended for adults on dialysis. Dialysis vs. Kidney Transplant- Estimated Survival in Ontario has been tested in a validation study of adults 18 years of age or older who have kidney disease. Dialysis vs. Kidney Transplant- Estimated Survival in Ontario has not been tested with children.

DATA WE COLLECT

As part of the Dialysis vs. Kidney Transplant- Estimated Survival in Ontario website, you may enter personal demographic and health-related data, such as age, race, gender, and previous medical conditions. This specific health information recorded in the Dialysis vs. Kidney Transplant- Estimated Survival in Ontario website is reported but is not personally identifiable. Once you finish the application and close it, no data are stored in Dialysis vs. Kidney Transplant-

Estimated Survival in Ontario. We may also collect aggregate information (data that are compiled in groups or according to a general category, and that are not personally identifiable). This aggregate data may include general usage statistics such as the number of sessions, and session length.
